



GENERAL TERMS AND CONDITIONS WOODEN MYWORLD©DAILYLIVING2015

- The quotes are valid up to 1 month after quotation date. Quotes can be subject to change by, for example, changes in the work or price changes of products.
- Prices are ex-factory, excluding VAT and excluding postage, unless otherwise stated at the invoice.
- DailyLiving has with consideration to the interest of the buyer, the freedom to use, for example, pictures of the Wooden MyWorld©, for his own publicity or promotion.
- Down payments must take place within 2 weeks of the invoice date. Similarly the last payment, but always before delivery. If after the expiry of that period the (full) payment is not received, the client is in default and owes interest equal to the legal interest rate. All costs incurred by DailyLiving, such as material costs, man hours, extrajudicial and judicial costs, including the costs for legal assistance, bailiffs and debt collection agencies, in connection with late payments, come at the expenses of the buyer. The extrajudicial cost are set at at least 10% of the invoice amount, with a minimum of €113,45.
- If, for any reason, the command ends prematurely, it does not allow the buyer (any longer) to use the designs made available and each license that is given to the client in the context of the assignment expires.
- The buyer is not entitled to a refund after paying all or part of the invoice amount of the WMW©.
- On the WMW© voids the damage warranty after purchase or, if agreed, after placement by DailyLiving.
- The WMW© is sent insured. When damage has occurred during transport, the buyer will **not** accept the package and will contact the carrier. When the damage is visible only after opening the packaging, then the following is of interest: take pictures of the packaging and padding (preferably with the package seal visible) and of the damaged contents of the shipment and contact the carrier.
- If, unfortunately, something should fail, the buyer will, within one year of the delivery date indicated on the certificate of authenticity, contact DailyLiving to see if it is possible to restore and whether there are costs.
- On the WMW© is copyright. This means that no copies may be made, nor of the included drawing. This drawing is intended to use as a mold for the WMW© to hang up properly.
- The drawing should after use be sent back immediately to DailyLiving.
- The buyer is not allowed any right out of the contract entered into with DailyLiving to transfer to third parties.
- DailyLiving takes care of the packaging and transport of the WMW© to the address given by the buyer.
- DailyLiving strives to deliver on the agreed delivery date and delivery address.
